**TWINNING AGREEMENT**  
**between**  
**the Municipality of**  
**BAIA MARE, Maramureş County, ROMANIA**  
**and**  
**the Municipality of**  
**POLIANYTSCA Village Council, Nadvirna District,**  
**Ivano Frankivsk Region, UKRAINE**

Considering the relations of friendship and cooperation between Romania and Ukraine based on mutual respect and support in various areas of common interest, the Municipality of Baia Mare, Maramureş County from Romania, and the Municipality of POLIANYTSCA Village Council, Nadvirna District,

Ivano Frankivsk Region, UKRAINE, hereinafter referred to as the Parties

Have agreed as follows:

**Article I**

**Objectives**

The Parties will cooperate to increase the institutional capacity of local public authorities in their administrative-territorial units with the objective of establishing partnerships in various areas of common interest for the economic and social development of the local communities they represent.

**Article II**

**Areas of Cooperation**

Based on the principles of bilateral cooperation, trust, equality, and mutual benefit, the Parties will develop cooperative relations in the following areas:

1. Public administration;
2. Culture and sports;
3. Economy and tourism;
4. Education;
5. Environment and public health;
6. Other areas of cooperation of mutual interest, according to the powers they have under the applicable laws of their countries, which will be subject to an additional act concluded under the same conditions as this twinning agreement, whose clauses remain unchanged.

### **Article III**

#### **Methods of Cooperation**

In accordance with their specific competences, the Parties will:

1. Develop relationships of friendship and mutual understanding between the inhabitants of the two communities, thereby contributing to their prosperity.
2. Contribute to identifying and exploiting opportunities to carry out joint actions in the fields of economy, society, environmental protection, tourism, culture, art, and education.
3. Will support the organization of exchanges of experience and good practices between delegations of specialists and representatives of local authorities and develop joint projects in the fields of economy, society, environmental protection, tourism, culture, art, and education, organizing joint events (festivals, exhibitions, sports competitions, etc.).

### **Article IV**

#### **Financial Aspects**

The Parties will independently bear the expenses incurred during the implementation of this Twinning Agreement, provided by the legislations in force in their countries.

### **Article V**

#### **Dispute Resolution**

Any dispute regarding the interpretation or application of this Twinning Agreement will be amicably resolved by the Parties through direct negotiations.

## **Article VI**

### **Coordination of Cooperation Activities**

Each Party will designate a coordinator to oversee the effective implementation of this Twinning Agreement. The coordinators designated by the Parties will develop an implementation plan and propose additional actions that can be undertaken by both parties.

## **Article VII**

### **Modification of the Twinning Agreement**

This Twinning Agreement may be amended or supplemented based on mutual written agreement of the Parties. The amendments and supplements will take effect on the date of signing.

## **Article VIII**

### **Implementation, Duration, and Termination**

1. This Twinning Agreement is concluded for an indefinite period and takes effect from the date of signing.
2. Either Party may terminate this Twinning Agreement by written notice to the other Party. In this case, the Agreement will cease to be valid on the 30th day from the date of notification.
3. The termination of this Twinning Agreement will not affect the implementation of programs and projects initiated during its validity period, unless otherwise agreed by the Parties.
