Please be informed that your project was selected by the Monitoring Committee to be awarded a grant of **1,224,759.32 EUR**, representing 90% from the total eligible costs.

The grant has been awarded under the following conditions (as recommended by the Project Selection Committee):

- To correlate the measurement period for Output 1.2RCO24_1.1: Investments in new or upgraded disaster monitoring, preparedness, warning and response systems against natural disasters according to Annex I to the Applicant's guidelines.
- To correlate the measurement period for results R2 and R3 according to Annex I to the Applicant's guidelines.

If you, as Lead Partner or the project partners **do not agree to sign a grant contract**, please provide a written notice explaining your decision, within **3 working days** from the date of the present notification, but no later than 18.02.2025.

If you accept the above-mentioned conditions, do note that during the preparation of the grant contract the JS will carry out checks to ensure the correctness of the project budget (e.g. inaccuracies and technical inconsistencies, removal of all ineligible costs and removal/reduction of costs according to the conclusions and recommendations of the Project Selection Committee). Also, any clarifications or minor corrections may be made to the description of the project or to the budget in so far they do not call into question the grant award decision, do not conflict with the equal treatment of all the applicants, relate to matters clearly identified by the Project Selection Committee and/or provided by the present Guidelines, or are absolutely necessary for the sound implementation of the project, under the conditions and in the framework established by the programme documents.

In order to prepare the grant contract dossier, you are required to provide the JS with the documents listed in Annex 1 (to be found bellow), as instructed.
